NOTICE is hereby given that at its regularly scheduled meeting on October 21, 2025, the Fresno County Board of Supervisors adopted Ordinance No. 25-025, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE

The Ordinance amends the Master Schedule of Fees, Charges, and Recovered Costs of the Ordinance Code of the County of Fresno (the "Ordinance Amendment") by adding Subsection 3803 - Fuel Per Gallon, amending Subsection 3811 - Fuel Tank Inspection, and by deleting subsections 3804 - Badge Identification, 3809 - Fleet Labor, 3810 - Motor Pool, 3812 - Building Maintenance Labor, 3813 - Janitorial Labor, and 3814 - County Parking of Section 3800 - General Services, relating to recovery of costs of Security, Fleet, and Facility Services.
