

SUMMARY
NOTICE is hereby given that at its regularly scheduled meeting on August 18, 2020, the Fresno County Board of Supervisors adopted Ordinance No. 20-014, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
The Ordinance will amend the Ordinance Code Pertaining to Election Contributions. The Ordinance adopted new section 2.62.040 of the Fresno County Ordinance Code to limit campaign contributions to candidates for County elective office from all persons to \$30,000 per election. The Ordinance also amended section 2.62.055 to include making it a misdemeanor to violate the provisions of section 2.62.040 and providing for penalties of a fine up to \$1,000 or imprisonment for up to six months, or both.
