Dear Garry Bredefeld,

The American Society for the Prevention of Cruelty to Animals (the “ASPCA”) is deeply honored to be able to grant to County of Fresno (the “Grantee,” and together with the ASPCA, the “Parties” and each a “Party”) the amount of \$ 50,000 (the “Grant”). These funds are designated for 2025 ASPCA California Wildfire & Disaster Preparedness Fund, as described in the Grant request, the Grant Request Documents, and, if applicable, its amendments (the “Project”) and subject to the terms of this agreement (the “Agreement”).

The ASPCA shall issue the Grant to the Grantee approximately two to six weeks following receipt of the signed original contract, including all pages. By signing this Agreement, you represent and warrant that Grantee will meet the obligations specified in this Agreement.

Intending to be legally bound and in consideration of the Grant provided to the Grantee and the desire of the Grantee to conduct the Project, the parties hereby agree to the following terms and conditions as of the first date listed above (the “Effective Date”):

1. Grant Requirements. The Grantee acknowledges and agrees that the Grant shall be used exclusively for costs incurred directly in connection with the Project and as set forth in this Agreement,

and that failure to do so will result in the Grantee having to return the Grant to the ASPCA within ten (10) days of the ASPCA's request to do so.

The Grantee acknowledges and agrees that any proposed changes to the Project, including, but not limited to, the Project goals and objectives, the use or purpose of funds, the distribution of funds across approved budget items, or any other substantive changes to the Project shall be fully approved by the Grant Officer and memorialized with an amendment to the Agreement prior to initiating any such changes.

Unless Grantee is expressly exempt from this requirement (e.g. as an agency or instrumentality of government), it shall meet the ASPCA Grantee Organizational Standards (the "Standards"), attached hereto as **Schedule 1**. If Grantee does not meet the standards by the Effective Date, the ASPCA may, in its sole discretion, grant additional time for the Grantee to come into compliance with the Standards. If additional time is granted, Grantee shall have 12-months or until the Expiration Date, whichever is sooner, to comply with the requirements and provide proof of compliance as a part of its required reporting.

The Grantee agrees that at no time will any funds it receives from the ASPCA be used to attempt to influence the outcome of any selection, nomination, election, or appointment of any individual to any public office or office of a political organization within the meaning of Internal Revenue Code Section 527(e)(2), and shall furthermore not use any of the funds it receives from the ASPCA to participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

For projects that include grant funds used to purchase food for a gathering of individuals, the Grantee will limit the use of ASPCA funds to purchase vegetarian, vegan, fish or welfare-certified meat products only. "Welfare-certified meat products" shall mean products that are from farms, obtained either directly or through another supplier (restaurant, retailer, etc.), that are certified by at least one of the following certification programs: (a) Animal Welfare Approved; (b) Certified Humane; and/or (c) Global Animal Partnership, Steps 2 and above. For more information about welfare-certified products or where to locate welfare-certified products, please visit <http://www.asPCA.org/take-action/help-farm-animals/finding-higher-welfare-products>.

Employees, volunteers or other associates of the Grantee whose food expenses are reimbursed or otherwise paid from ASPCA grant funds, including, but not limited to beneficiaries of travel stipends and scholarships, are strongly encouraged to choose higher-welfare meat products, fish, vegan or vegetarian food.

Grant Reporting:

The Grantee must submit reports (the "Grant Reports") to provide the ASPCA with information about the Project and to ensure the Grant is being used as described in this Agreement. Grant Reports shall be due per the following schedule:

The Grantee acknowledges it may be subject to additional reporting requirements as assigned by its ASPCA Grant Officer and set forth in the Grant record in Fluxx (the “Additional Reporting”). Additional Reporting shall be submitted as a part of the regular Grant Reports.

Grantees that fail to submit required documentation by the Final Report Due Date may jeopardize future grants and/or grant payments.

Grant Extensions:

Extension requests will not be considered for the Final Report Due Date. However, should the Grantee need a Grant extension due to unforeseen delays in the Project timeline, Grantee may request an extension by emailing grants@aspc.org before the Grant Expiration Date. The ASPCA shall review the Grantee’s request and may grant an extension to the Grant term. If the ASPCA declines the request for an extension, or if the Project is completed but carries a balance of unspent funds, the Grantee shall promptly refund and pay back to the ASPCA the unexpended balance.

Ad Hoc Requirements:

The ASPCA may request additional information regarding the Project. Upon such a request, the Grantee must provide the requested information in a timely manner. Such additional information may include but is not limited to receipts, photographs, and press information.

The ASPCA may choose to conduct site visits of the Grantee’s location(s). The Grantee must provide the ASPCA with access to such locations at a date and time mutually agreed upon by the Parties.

2. Compliance with the Law and Maintenance of Tax-Exempt Status. In carrying out the Project, the Grantee shall comply with all applicable federal, state and local laws and regulations including but not limited to all applicable federal, state, and local employment laws, regulations, and rules.

The Grantee agrees that it is the sole employer of all individuals who are compensated in whole or in part with Grant funds, or whose employment, fellowship or internship position arises in any way as a direct or indirect result of the Grant (each a “Funded Position”). The Grantee further agrees that it is exclusively responsible for the classification and engagement of any contractors whose fees and/or expenses are paid in whole or in part with Grant funds (“Funded Contractor”). Accordingly, the Grantee agrees that with respect to any Funded Position and/or any Funded Contractor, the Grantee is exclusively responsible for compliance with, and will comply with, any and all applicable federal, state and local employment laws, regulations and rules, including, but not limited to, any employer obligations to: (a) timely pay all wages or other compensation due; (b) withhold and remit employment taxes; (c) administer any required discipline; (d) provide insurance coverages; (e) prohibit discrimination or harassment based on any protected characteristic; and (f) provide any required leave or accommodation. The Grantee acknowledges and agrees that the parties to this Agreement are in the relationship of Grantor and Grantee, and the use of Grant funds for Funded Positions and/or Funded

Contractors does not constitute a joint venture, affiliation, or joint employment relationship of any kind.

If the Grantee is a 501(c)(3) organization, the Grantee certifies that it is in good standing with the Internal Revenue Service and shall notify the ASPCA immediately of any change in, or challenge by the Internal Revenue Service to, its status as a 501(c)(3) tax-exempt organization.

3. License. Each Party hereby grants to the other party a license to use the Party's name and trademarks on materials directly related to the activities of the Project and/or the Grant.

All use of the ASPCA name and trademarks must comply with the ASPCA's style guide. "ASPCA Trademarks" are: "ASPCA®", which must always appear in PMS 422 and 021, unless used in materials that are completely black and white in nature, in which case it may appear in black; and "The American Society for the Prevention of Cruelty to Animals®".

4. Acknowledgement of ASPCA Support. In consideration of the Grant, the Grantee may publicly acknowledge that the Project was made possible through a generous grant from the ASPCA. If the Grantee chooses to make an acknowledgment, Grantee shall submit any Project acknowledgements that include the ASPCA's name or trademarks to press@aspca.org for review and approval prior to its inclusion in any materials prepared and intended to be distributed regarding the activities of the Project. No changes on the approved version of any Project acknowledgements shall be instituted by the Grantee without the prior written approval of the ASPCA. The ASPCA has the right in its sole discretion to require the Grantee to remove all references to the ASPCA's involvement if the ASPCA determines that the Grantee is not fulfilling its obligations under this Agreement or if for any other reason the ASPCA determines that it is no longer in the ASPCA's best interest to be referenced in such manner.

5. Records. The Grantee will keep accurate books and records with respect to the grant in accordance with Generally Accepted Accounting Principles (GAAP) and business practices. The Grantee will keep records of receipts and expenditures made of Grant funds as well as copies of the reports submitted to the ASPCA and supporting documentation for at least three (3) years after completion of the use of the Grant funds, and will furnish or make available such books, records, and supporting documentation to the ASPCA for inspection at reasonable times from the time of the Grantee's acceptance of the Grant through such period.

6. Termination. The ASPCA may, in its sole discretion (i) withhold payment of funds until in its opinion the situation has been corrected or (ii) declare the Grant terminated in any of the following circumstances:

- a. If, as the result of the consideration of reports and information submitted to it by the Grantee or from other sources, the ASPCA, in its sole discretion, determines that continuation of the Project is not reasonably in furtherance of the ASPCA's mission to provide effective means for

the prevention of cruelty to animals throughout the United States (the “ASPCA Mission”) or that the Project is not being executed in substantial compliance with the grant request (or work plan as revised) or that the Grantee is incapable of satisfactorily completing the work of the Project;

- b. In the case of any violation by the Grantee of the terms and conditions of this Agreement;
- c. In the event of any change in, or challenge by the Internal Revenue Service to, the Grantee’s status as a 501(c)(3) tax-exempt organization if applicable; or
- d. If it is revealed that, during the Project, the Grantee is or was involved in any activity or makes any statement disparaging of, or reflecting unfavorably upon the ASPCA, tarnishes the reputation of the ASPCA or is not in alignment with the ASPCA Mission.

If the ASPCA terminates the Grant, it shall so notify the Grantee, whereupon it, if so requested by the ASPCA, shall promptly refund and pay back to the ASPCA any unexpended balance of the Grant funds in the Grantee’s hands or under its control or any expended Grant funds deemed to have been misappropriated per the terms of this Agreement.

Upon completion of the Project or termination of this Agreement for any reason, the ASPCA will withhold any further payments of Grant funds. All such determinations by the ASPCA under this **Section 6** will be final, binding and conclusive upon the Grantee.

7. Future Funding. The Grantee acknowledges that the ASPCA and its representatives have made no actual or implied promise of funding except for the amounts specified in this Agreement. If any of the Grant funds are returned or if the Grant is rescinded, the Grantee acknowledges that the ASPCA will have no further obligation to the Grantee in connection with this Grant as a result of such return or rescission.

8. Miscellaneous. This Agreement is intended to be binding upon the Grantee and the ASPCA. This Agreement represents the final agreement between the parties with respect to the subject matter hereto, and supersedes any and all prior agreements, written or oral, between the parties with respect to the matters contained herein. This Agreement is not intended to, nor shall it be deemed to create, any partnership or joint venture between the Grantee and the ASPCA. This Agreement shall be interpreted, governed by and construed in accordance with the internal laws of the State of New York, without regard to the conflict of laws principles thereof. The parties hereto acknowledge and consent to personal jurisdiction and venue exclusively in New York, New York with respect to any action or proceeding brought in connection with this Agreement. This Agreement may be executed by the parties hereto in counterparts, each of which, when executed and delivered, shall be deemed to be an original and all of which shall constitute together the same document.

If the terms and conditions of this Agreement are acceptable, please sign this Agreement and return it to us. By signing this Agreement, you represent and warrant that you are capable of binding the Grantee to the terms set forth in this Agreement.

Services and Support to Be Provided -

We are seeking funding to provide the following key services:

Animal Care Supplies - Providing emergency kits that include leashes, collars, crates, litter, bowls, and other basic care items necessary for temporary sheltering and evacuations.

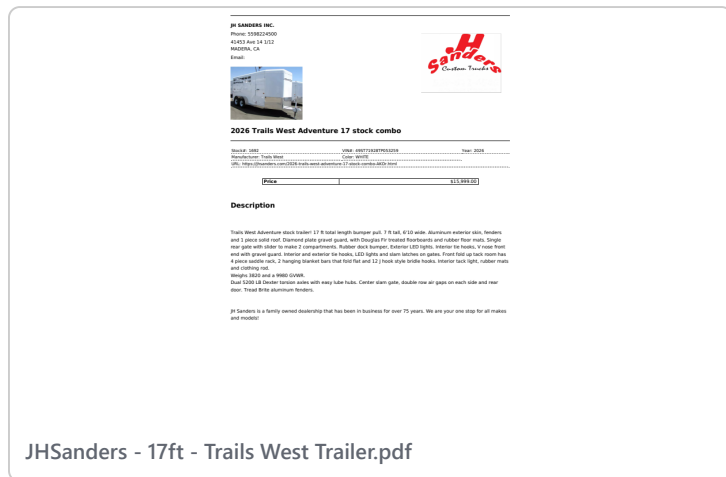
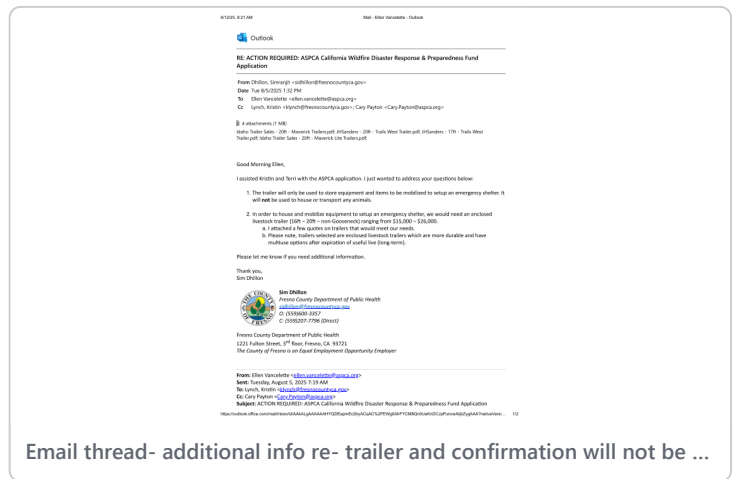

Capacity-Building

Please provide a brief summary of your organization's participation and role in responding to disasters over the past two years:

Fresno County Animal Shelters, led by Fresno Humane Animal Services, have played an essential role in wildfire response and preparedness throughout California's Central Valley. Over the past two years, our organization has actively responded to wildfire emergencies, while simultaneously investing in infrastructure, planning, and partnerships to enhance long-term disaster readiness.

June 2024 – Lightning Complex Fires & Basin Fire Response

In June 2024, Fresno County experienced a series of devastating wildfires in its eastern foothills. Fresno County activated its Emergency Operations Center (EOC), triggering a multi-agency coordinated response. Fresno Humane Animal Services immediately deployed field officers, transport vehicles, and staff to support the evacuation and sheltering of animals impacted by the fires.

Small Animal Support: Working alongside the American Red Cross, our team managed the intake and care of evacuated pets at the Reedley College shelter site.

Large Animal Operations: In partnership with the Central California Animal Disaster Team (CCADT), we facilitated transport and care of livestock and equines at the Fresno Fairgrounds and Clovis Rodeo Grounds.

24/7 Field Operations: Animal services personnel conducted welfare checks and feeding operations in evacuated zones where shelter-in-place was authorized.

September 2023 – Wildfire Risk Activation

Prolonged heatwaves and high fire risk in late 2023 prompted precautionary readiness measures in the foothill and Clovis Unified School District areas. While full evacuations were not ordered, Fresno Humane Animal Services pre-staged crates, transport trailers, and staff at Granite Ridge Intermediate School, Clovis North High School, and the Fresno Fairgrounds to receive animals if needed.

Community Engagement: Outreach materials on pet evacuation kits and microchipping were distributed in high-risk neighborhoods, in both English and Spanish.

On-call Surge Capacity: CCADT volunteers and local veterinary partners remained on standby for medical triage or shelter setup.

Capacity-Building Initiatives for Future Wildfire Preparedness

In addition to real-time emergency response, our organization has taken significant steps to build capacity for future disaster resilience:

1. Infrastructure Expansion (Completed April 2022)

Fresno Humane Animal Services opened a new 20,000 sq ft, climate-controlled facility in Fowler, CA. This modern center includes:

- A dedicated intake wing with quarantine and isolation capabilities

- A vaccination and spay/neuter clinic to prevent disease spread during disaster sheltering

- Enhanced HVAC, waste management, and animal handling systems to maintain humane care during high-volume operations

This facility now serves as our primary disaster response coordination hub.

2. Strategic Planning and Interagency Coordination

We have continued to refine Fresno County's Animal Evacuation and Sheltering Plan, aligning with SEMS (Standardized Emergency Management System) and NIMS (National Incident Management System) protocols. Our team participates in annual tabletop exercises and multi-agency coordination meetings facilitated by the County Office of Emergency Services.

3. Training and Preparedness Investment

Staff and volunteers regularly engage in ASPCA, CalAnimals, and Humane Society of the United States (HSUS) disaster training programs. These include courses on:

- ICS (Incident Command System) for Animal Response
- Large Animal Rescue Techniques
- Shelter Operations in Disaster Settings
- Behavioral and Medical Triage During Evacuations

4. Partner Engagement

We maintain formal partnerships with organizations including:

- CCADT (Central California Animal Disaster Team) – Providing transport, field operations, and volunteer mobilization
- Fresno County Office of Emergency Services – EOC coordination and logistical planning
- Local Veterinary Clinics and Mobile Services – Offering emergency care, vaccinations, and temporary housing

Fresno County Animal Shelters have demonstrated a proactive, organized, and collaborative approach to wildfire preparedness. Through direct response to wildfire emergencies and strategic capacity-building investments—especially in infrastructure, training, and community partnerships—we have laid the foundation for a sustainable, scalable, and humane disaster response model.

Funding through the ASPCA Capacity-Building Grant will allow us to further expand on this momentum, acquire additional emergency sheltering supplies, enhance mobile response capacity, and conduct regional preparedness outreach to protect vulnerable animals before, during, and after future wildfire events.

Over the past several years, Fresno County Animal Shelter has taken proactive and sustained steps to build our disaster response capacity and enhance community preparedness in the face of wildfires and other emergencies. Recognizing the escalating threat of natural disasters in California, our organization has prioritized resilience-building through infrastructure upgrades, cross-agency coordination, and public education initiatives.

Our team has conducted and participated in multi-agency emergency response drills, including annual wildfire evacuation exercises coordinated with the Fresno County Office of Emergency Services and local fire departments. These exercises have refined our protocols for safe animal intake, temporary sheltering, medical triage, and reunification with owners during active fire events.

To improve our internal capabilities, we have invested in critical equipment such as portable kennels, mobile microchipping stations, and emergency feed and water supplies. We have also established an on-call Disaster Response Team trained in animal rescue operations, ICS protocols, and animal handling in hazardous environments.

Beyond internal capacity, we have focused on strengthening our role in the community. In partnership with local nonprofits and emergency managers, we have hosted wildfire preparedness outreach events targeting rural and high-risk areas. These events included distribution of pet evacuation kits, emergency ID tags, and informational materials on animal evacuation planning.

In 2023 and 2024, we implemented a community microchipping and vaccination campaign that reached over 1,000 pets in vulnerable areas. These efforts directly support disaster readiness by increasing the

likelihood of safe reunification during evacuations and decreasing disease transmission in emergency shelters.

Please describe in detail your plans to build capacity to improve your community's response to future disasters:

Fresno County Animal Shelter continues to advance our mission through improved planning, resources, and community engagement. With additional support, we aim to build on this foundation to further strengthen our disaster response efforts. To future wildfires and other disasters, we are seeking funding to establish a fully equipped, rapidly deployable Emergency Animal Shelter Mobilization Unit. This initiative represents a critical enhancement to our county's emergency preparedness infrastructure, ensuring timely and humane support for animals impacted by disaster events.

The core of this plan involves the acquisition and outfitting of a dedicated trailer, which will serve as both a mobile storage and deployment hub for all necessary animal sheltering equipment and supplies. This unit will be pre-loaded and maintained in a state of readiness, allowing for immediate activation and rapid deployment to disaster-affected areas.

Primary Objectives of the Mobilization Unit:

1. Immediate Deployment of Temporary Animal Shelters:
2. The mobilization unit will enable our staff and volunteers to establish a fully operational temporary animal shelter within hours of an emergency declaration. This capacity is essential for providing urgent care to animals displaced by wildfires, floods, and other regional disasters during the critical early phase when chaos and displacement are at their peak.
3. Sustained Animal Welfare Operations:
4. The supplies housed within the trailer—including kennels, crates, veterinary supplies, animal food, cleaning and sanitation materials, and climate control equipment—are sufficient to support ongoing operations for a prolonged period. This ensures that sheltering efforts can be maintained until animals can be returned to their owners or relocated to longer-term care facilities.

Expected Impact:

Faster Emergency Response: The trailer will eliminate time lost sourcing and transporting supplies, enabling Fresno County to deliver on-the-ground services much more quickly.

Enhanced Community Trust and Resilience: Public confidence in local emergency services will grow knowing that both human and animal family members are accounted for in disaster planning and response.

Support for Broader Recovery Efforts: Quick animal care deployment allows families to focus on securing their own safety and recovery without the added stress of concern for their pets or livestock.

This strategic investment in emergency animal sheltering infrastructure will significantly bolster our capacity to respond compassionately and effectively in future disaster scenarios, ensuring that Fresno County remains resilient, responsive, and well-prepared.
