ALL THAT REAL PROPERTY SITUATED IN THE CITY OF REEDLEY, COUNTY OF FRESNO, STATE OF CALIFORNIA AND BEING A PORTION OF THE MAP OF THE TOWN OF REEDLEY, FILED IN BOOK 5 OF PLATS AT PAGE 6, FRESNO COUNTY RECORDS AND LYING WITHIN THE SOUTHEAST QUARTER OF SECTION 27, TOWNSHIP 15 SOUTH, RANGE 23 EAST A MOUNT DIABLO BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE NORTHWESTERLY RIGHT-OF-WAY OF 11TH STREET AND SOUTHWESTERLY RIGHT-OF-WAY OF "H" STREET (ALSO KNOWN AS THE TULARE VALLEY RAILROAD AND REEDLEY COMMUNITY PARKWAY); THENCE SOUTH 49°50'15" WEST ALONG THE NORTHWESTERLY RIGHT-OF-WAY OF SAID 11TH STREET, A DISTANCE OF 124.99 FEET TO A POINT WHICH MEASURES 25.00 FEET RADially FROM THE CENTER OF A RAILROAD SPUR, THENCE PARALLEL WITH AND 25.00 FEET FROM THE CENTERLINE OF SAID RAILROAD SPUR, A DISTANCE OF 119.91 FEET ALONG THE ARC OF A NON-TANGENT CURVE TO THE RIGHT, CONCAVE NORTHEASTERLY, HAVING A RADIUS OF 975.00 FEET, A CENTRAL ANGLE OF 7°02'47", AND A RADIAL WHICH BEARS SOUTH 50°40'34" WEST; THENCE NORTH 32°16'39" WEST CONTINUING PARALLEL WITH AND 25.00 FEET FROM THE CENTERLINE OF SAID RAILROAD SPUR, A DISTANCE OF 81.22 FEET; THENCE LEAVING SAID SPUR, NORTH 49°51'07" EAST AND PARALLEL WITH THE SOUTHEASTERLY RIGHT-OF-WAY OF 10TH STREET, A DISTANCE OF 104.75 FEET TO THE SOUTHWESTERLY RIGHT-OF-WAY OF "H" STREET; THENCE SOUTH 40°09'28" EAST ALONG SAID SOUTHWESTERLY RIGHT-OF-WAY, A DISTANCE OF 199.91 FEET TO THE TRUE POINT OF BEGINNING.
