RESOLUTION

WHEREAS, the County of Fresno, Internal Services Department - Fleet Services, Org 8910, requires an increase in appropriations in the amount of \$525,000 to allow for the ongoing payment of vehicle costs related to fuel, maintenance and repairs necessary to meet user department demands and use; and

WHEREAS, said additional costs will be financed by revenue from user county departments benefiting from said maintenance services and fuel operations; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2019-20 Fleet Services, Org 8910 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2019-20 Fleet Services, Org 8910 as follows:
