\*\* Depending on the type(s) of record(s) requested, the type(s) of copy(ies) requested, and the requested media and manner of providing such type(s) of copy(ies), the Sheriff's Office will select the applicable process(es), above, and charge the requestor for the cost(s), above, of such process(es), plus applicable labor rate(s), as determined by Sheriff's Office [see u., v., w., and x., above], and applicable media and delivery costs, above.

\*\*\* Audio, Video, Dispatch Audio Tape Records, and Other Electronic Records: Cost of producing a copy of the audio, video, or dispatch audio tape record(s), or other electronic record(s), including for any such record(s), as applicable, (1) the cost to construct any record(s), and (2) the cost of programming and computer services necessary to produce a copy of the record(s) when either of the following applies: (a) the request would require data compilation, extraction, and/or programming to produce the record(s); or (b) to produce a copy of a record(s) that is produced only at otherwise regularly scheduled intervals. Other electronic records may include, but are not limited to, any non-paper records referenced in the notes (\*) and (\*\*), above.
