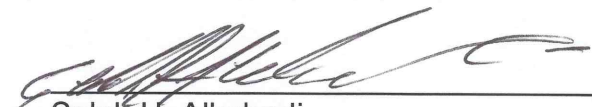

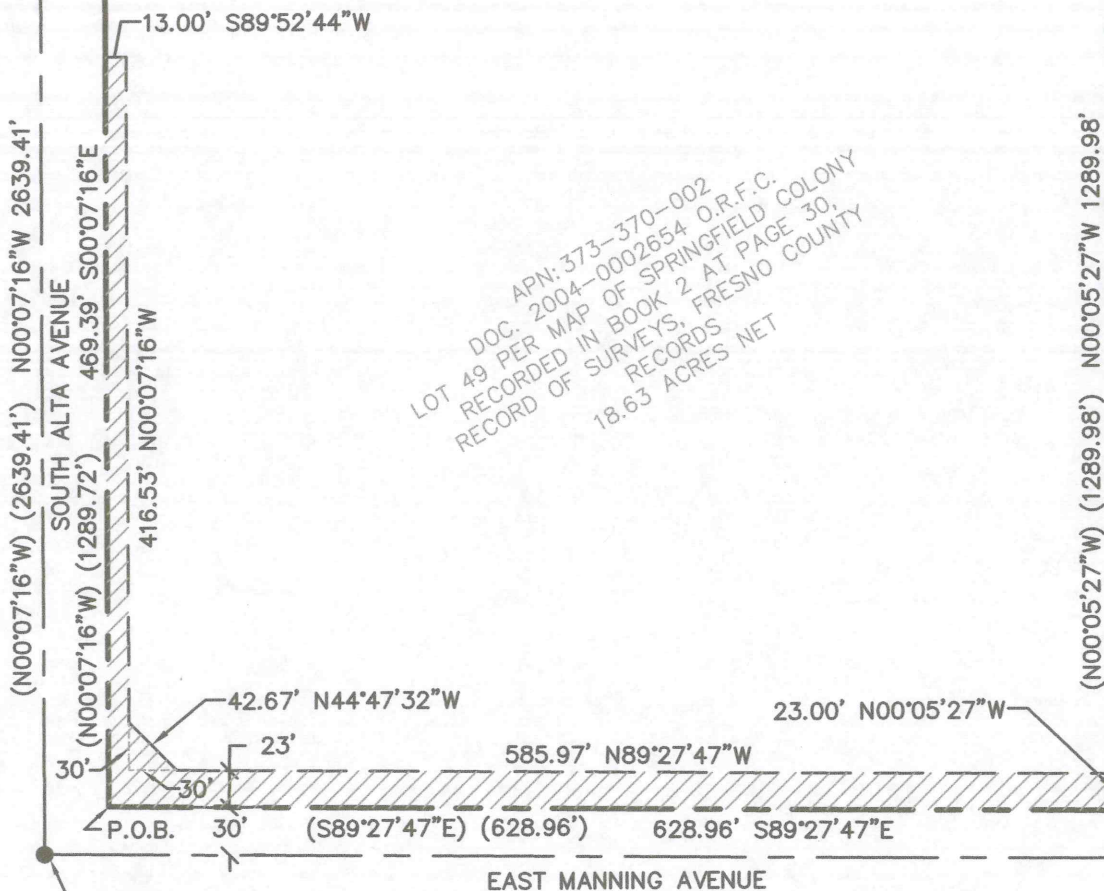

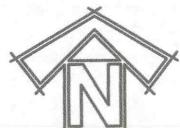


EXHIBIT "B" SCALE: 1" = 120'
