WHEREAS, the Crisis Care Mobile Units Grant Org 1085 requires \$204,356 to meet expenditures; and

WHEREAS, the Crisis Care Mobile Units Grant Org 1085 requires an increase in appropriations to fund an Operating Transfer Out in the amount of \$204,356 to the Behavioral Health Org 5630; and

WHEREAS, sufficient funds are available in the Fund Balance of the Dept of Behavioral Health fund 0041, Subclass 17133, Org 1085 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2023-24 Crisis Care Mobile Units Grant Org 1085; and


WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;
