WHEREAS, the total costs for the building 319 renovations project is estimated at \$1,500,000;
and

WHEREAS, the Behavioral Health Org 5630 requires an increase in appropriations and estimated revenues to fund an Operating Transfer Out in the amount of \$1,500,000 to the DBH – Capital Projects Org 8859 to fund the costs for the building 319 renovations project; and

WHEREAS, Behavioral Health Org 5630 will receive funds as an Operating Transfer In from the Capital Facilities Org 1055; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for FY 2017-18 Behavioral Health Org 5630; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Behavioral Health Org 5630 as follows:


