PUBLICATION OF SUMMARY OF PROPOSED ORDINANCE BOARD OF SUPERVISORS COUNTY OF FRESNO

The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on March 23, 2021 at 10:00 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

Revise Section 2.44.060 of Chapter 2.44 of Title 2 - Administration - to provide that the board of supervisors shall review the need to continue a local emergency proclamation at least once every sixty (60) days, consistent with Government Code section 8630(c). The Ordinance revision will take effect and be in force thirty (30) days from and after passage.
