WHEREAS, the Social Services Fund 0065, Subclass 17237, Homeless Services Org 1132 will need to appropriate an additional \$3,675,284 to meet unanticipated expenses associated with Homeless Services for FY 2020-21; and

WHEREAS, said monies were not included in the FY 2020-21 adopted appropriations of the Homeless Services Org 1132; and

WHEREAS, sufficient funds are available in the Fund Balance of the Homeless Services Org Fund 0065, Subclass 17237, Org 1132 to fund these expenditures; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Homeless Services Org 1132 as follows:


