WHEREAS, the Department of Public Works and Planning Organization 9301 requires \$157,500 to meet expenditures associated with the purchase of power generating equipment; and

WHEREAS, the California Governor's Office of Emergency Services (Cal OES) approved the Department of Public Works and Planning's FY 2020-21 Community Power Resiliency allocation in the amount of \$157,500; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the Public Works and Planning Revenue Fund 0230, Subclass 12150, Organization 9301; and

WHEREAS, \$157,500 is not included in the FY 2020-21 adopted appropriations of the Public Works and Planning Organization 9301; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Public Works and Planning Organization 9301 as follows:


