SUPERVISOR MAGSIG REPORTED CONCLUDING HIS TWO-YEAR TERM SERVING ON THE SIERRA NEVADA CONSERVANCY, WHICH IS RESPONSIBLE FOR ISSUING GRANTS TO MANAGE OUR MOUNTAINS AND FORESTS APPROPRIATELY. VICE CHAIRMAN QUINTERO ANNOUNCED THE HMONG NEW YEAR WAS HELD AT THE FRESNO FAIRGROUNDS WHERE COVID-19 VACCINATIONS WERE AVAILABLE; 567 VACCINES WERE ADMINISTERED, WITH 18 FOR TEENAGERS RANGING FROM 12-17 YEARS OLD. SUPERVISOR BRANDAU ATTENDED THE MARTIN LUTHER KING, JR. GARLANDING CEREMONY WITH CHAIRMAN PACHECO ON FRIDAY, JANUARY 14 IN COURTHOUSE PARK. SUPERVISOR BRANDAU DETAILED THE CONCEPT OF THE LAW ENFORCEMENT MACHINE/TEAM TO PUT BAD PEOPLE BEHIND BARS; EXPLAINED THAT THERE IS A LOT OF WORK FROM DIFFERENT PARTS OF THE MACHINE, BESIDES THE PEOPLE MAKING ARRESTS, TO MAKE SURE BAD PEOPLE STAY BEHIND BARS, INCLUDING MANY PROFESSIONALS IN THE DISTRICT ATTORNEY'S OFFICE WITH ADVANCED DEGREES AND SPECIALIZED TRAINING TO ENSURE OUR COMMUNITY IS PROTECTED; AND RECOGNIZED THEIR CRUCIAL ROLE IN THE PROCESS. SUPERVISOR BRANDAU EXPRESSED THAT ALTHOUGH HE DID NOT SUPPORT AGENDA ITEM 35 AS HE DOESN'T AGREE WITH THE CONCEPT OF SPENDING TAXPAYER MONEY ON THAT ITEM, HE APPRECIATES AND VALUES FRESNO COUNTY EMPLOYEES AND WOULD PREFER TO HAVE EMPLOYEES COMPENSATED IN THEIR PAY, NOT A ONE-TIME PAYMENT. SUPERVISOR MENDES ANNOUNCED BEING SELECTED AS CHAIRMAN FOR THE URBAN COUNTIES CAUCUS (UCC) AND REPORTED THE UCC OFFICIALLY ADOPTED A WATER POLICY WITH SUPPORT FROM BAY AREA SUPERVISORS. CHAIRMAN PACHECO MENTIONED THE NEED TO REMEMBER AND RECOGNIZE CORRECTIONAL OFFICERS AS PART OF THE LAW ENFORCEMENT TEAM WITH A VERY HAZARDOUS JOB, ESPECIALLY WITH THE COVID-19 SITUATION
