WHEREAS, the Foundation for Fresno County Public Library donated a monetary donation of \$31,500 to the Fresno County Public Library for the restricted use of the development of a Digibus Mobile Classroom. The \$31,500 is a portion of the total cost of \$179,386 required for the development of the Digibus Mobile Classroom. The cost associated with the transition of the existing Winnebago into a Digibus Mobile Classroom is \$90,000; and

WHEREAS, the County Library Book Fund Organization 7521 requires an increase in appropriations and estimated revenues to allow for a transfer to the Fleet Services-Equipment Organization 8911; and

WHEREAS, said monies are not included in the FY 2016-17 appropriations and estimated revenues of the County Library Book Fund Organization 7521; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 County Library Book Fund Organization 7521 as follows:
