NOTICE is hereby given that at its regularly scheduled meeting on April 17, 2018, the Fresno County Board of Supervisors adopted Ordinance No. 18-005, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE

This Ordinance amends the Fresno County Master Schedule of Fees by amending Section 1800-Probation, whereby subsections 1802, 1804, 1809, 1815 and 1817 relating to recovery of costs by the Probation Department for detention, supervision and electronic monitoring of juveniles in the delinquency system are deleted, as such fees and costs may no longer be assessed pursuant to State Senate Bill 190 which went into effect on January 1, 2018.

This Ordinance amends the Fresno County Master Schedule of Fees by amending subsection 2001 of Section 2000-Public Defender, relating to Fees Collected for Services Provided on Indigent Criminal Defendants, by deleting all fees relating to legal services provided to juveniles in the delinquency system, which may no longer be assessed pursuant to State Senate Bill 190 which went into effect on January 1, 2018.
