WHEREAS, California Elections Code section 10002, permits the governing board of a city or district to approve and execute a resolution requesting a county's board of supervisors to permit the county elections official to render services relating to the conduct of an election; and

WHEREAS, California Elections Code section 10400 et. Seq., and other state laws permit consolidation of elections and sharing of election costs by cities, counties, school districts, other public districts, and other public entities by order of the County Board of Supervisors; and

WHEREAS, the Fresno County Clerk/Registrar of Voters is the county elections official in Fresno County; and

WHEREAS, the city of Coalinga adopted Resolution Number 3771 on July 17, 2017, respectfully, requesting the Fresno County Clerk/Registrar of Voters conduct the November 7, 2017 Special Municipal Election and canvass the returns; and

WHEREAS, the City of Coalinga has requested consolidation with the Uniform District Election Law (UDEL) election; and

WHEREAS, the Riverdale Irrigation District will hold a regularly scheduled election under the UDEL on November 7, 2017; and

1 WHEREAS, in Resolution Number 3771, the City of Coalinga consents to reimburse the
2 County Clerk/Registrar of Voters for all costs incurred by said services;

3 NOW, THEREFORE, BE IT RESOLVED:

- 4 1. The Board of Supervisors authorizes the Fresno County Clerk/Registrar of Voters to
5 conduct the November 7, 2017 City of Coalinga Special Municipal Election.
6 2. The Board of Supervisors orders the consolidation of the City of Coalinga Special
7 Municipal Election with the November 7, 2017 UDEL election for Riverdale Irrigation
8 District.
9 3. The Board of Supervisors authorizes the County Clerk/Registrar of Voters to bill the
10 City of Coalinga for their costs related to the conduct of the November 7, 2017
11 Consolidated Special Municipal Election and the City of Coalinga to reimburse the
12 County for such costs.
