ORGANIZATION 9028 IN THE AMOUNT OF \$470,000)

WHEREAS, the Blue Hills Hazardous Disposal Facility is regulated by the
Department of Toxic Substances Control (DTSC); and

WHEREAS, DTSC requires the County of Fresno to provide a variety of technical
reports, estimated to cost up to \$470,000 and associated with an application for a
Hazardous Waste Facility Post Closure Permit; and

WHEREAS, the Coalinga Disposal Site Organization 9028 requires an increase
in appropriations in the amount of \$470,000 to fund an Operating Transfer Out to the
Misc Pass-Through Org 43601250; and

WHEREAS, \$470,000 is available in the general reserves of the Coalinga
Disposal Site Fund 0710, Subclass 15000 to fund the increased costs for the Blue Hills
Hazardous Disposal Facility; and

WHEREAS, said monies are not included in the adopted appropriations of the FY
2017-18 Coalinga Disposal Site Organization 9028; and

WHEREAS, Section 29130 of the Governmental Code provides for the
appropriation of these funds by a 4/5ths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax
Collector is authorized to increase the appropriations in the FY 2017-18 Budget for
Coalinga Disposal Site Organization 9028 as follows:
