Enrollment Site Fee for Service Pay Schedule**

As referenced in the ADAP Enrollment Site contract under 'Exhibit B - Budget Detail and Payment Provisions', the following references the fee for service pay schedule for ADAP Enrollment Sites. This fee schedule is subject to change. ADAP will notify enrollment sites two weeks prior to implementing updated service rates.

**Updated: March 8, 2018**

Fiscal Year (FY) 2017-18: All ADAP enrollment sites with a minimum of one ADAP or Pre-Exposure Prophylaxis Assistance Program (PrEP-AP) enrollment per FY, will receive a floor amount of \$5,000 with additional payment(s) per FY for performing the following ADAP/PrEP-AP services complete with all required forms and verifying documentation:

- New ADAP Medication Program Enrollments: \$100/per new enrollment
- New ADAP Insurance Assistance Program enrollments (including Medicare Part D Premium Assistance Program): \$275/per new enrollment
- ADAP bi-annual recertification: \$30/per recertification
- ADAP annual re-enrollments: \$100/per re-enrollment
- Insurance Assistance Program annual re-enrollments (including Medicare Part D Premium Assistance Program): \$125/per re-enrollment
- New PrEP-AP enrollments: \$100/per new enrollment
- PrEP-AP re-enrollments: \$100/per re-enrollment
- Paid Insurance Assistance Medical Out-of-Pocket (MOOP) Claims: \$20/per paid Insurance Assistance MOOP
- Paid PrEP-AP MOOP Claims: \$20/per paid PrEP-AP MOOP

FY 2018-19 and FY 2019-20: All ADAP enrollment sites with a minimum of one ADAP or PrEP-AP enrollment per FY will receive a floor amount of \$2,500 with additional payment(s) per FY for performing the following ADAP/PrEP-AP enrollment services complete with all required forms and verifying documentation:

- New ADAP Medication Program enrollments: \$50/per new enrollment
- New ADAP Insurance Assistance Program enrollments (including enrollment into Private Insurance and Medicare Part D): \$100/per new enrollment
- ADAP bi-annual recertification: \$10/per recertification
- ADAP annual re-enrollments: \$50/per re-enrollment
- Insurance Assistance Program annual re-enrollments (including Medicare Part D Premium Assistance Program): \$50/per re-enrollment
- New PrEP-AP enrollments: \$50/per new enrollment
- PrEP-AP re-enrollments: \$50/per re-enrollment
- Paid Insurance Assistance MOOP Claims: \$10/per paid Insurance Assistance MOOP
- Paid PrEP-AP MOOP Claims: \$10/per paid PrEP-AP MOOP
