

1 AMENDMENT I TO AGREEMENT

2 THIS AMENDMENT I TO AGREEMENT, hereinafter referred to as Amendment I, is made
3 this 21st day of August, 2018, by and between the COUNTY OF FRESNO, a political
4 subdivision of the State of California, hereinafter referred to as the "County", and the DEL REY
5 COMMUNITY SERVICES DISTRICT, hereinafter referred to as the "District".

6 WITNESSETH

7 WHEREAS, the County has been designated as the sponsoring agency to administer and
8 implement the Community Development Block Grant (CDBG) Program activities of the County,
9 and its participating cities, in accordance with the provisions of Title I of the Housing and
10 Community Development Act of 1974, as amended, and the laws of the State of California; and

11 WHEREAS, on August 8, 2017, the County and the City entered into Agreement 17-427,
12 hereinafter referred to as the "Agreement", whereby \$250,000 in CDBG funds were made available
13 to the District for the Del Rey Emergency Generators and Sewage Grinder, Project No. 16151,
14 hereinafter referred to as the "Project"; and

15 WHEREAS, the District informed the County that the total estimated cost of the Project has
16 increased from \$250,000 to \$410,560 due to increased construction costs; and

17 WHEREAS, the County now has an additional \$160,560 of CDBG funds that can be made
18 available to the Project to accommodate the increased construction costs; and

19 WHEREAS, the District has requested these additional CDBG funds in the amount of
20 \$160,560 be made available to the Project.

21 NOW THEREFORE, in consideration of their mutual promises as hereinafter set forth, the
22 District and the County agree to amend the Agreement as follows:

23 1. That the proposed Project budget on Page 2, Lines 21 through 23 be amended to
24 read:

"Construction	\$351,100
Design & Construction Engineering	47,500
Contingency, Permits & Misc.	<u>11,960</u>
Total	\$410,560"

28 2. That the proposed funding summary on Page 3, Lines 3 and 4 be amended to read:

1	"CDBG	\$410,560
2	Local Financial Contribution	<u>0</u>
	Total	\$410,560"

3. That the dollar figure set forth on Page 1, Lines 16 and 17, Page 2, Line 26, Page 3, Line 17, and Page 4, Line 22, be amended in each such place to read "\$410,560".

All remaining provisions, terms, covenants, conditions, and promises contained in said Agreement dated August 8, 2017 shall remain in full force and effect.

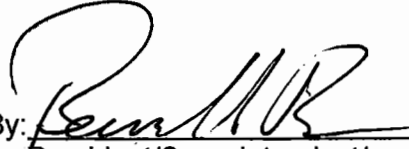

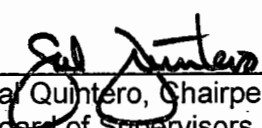

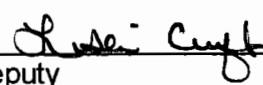
