WHEREAS, the Aid to Families with Dependent Children-Foster Care Organization will receive \$986,510 in State Funds, due to the increase in Short Term Residential Therapeutic Program placement which resulted in the increase in expenditures in the Foster Care Program; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Aid to Families with Dependent Children-Foster Care Organization 6410; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Aid to Families with Dependent Children-Foster Care Organization 6410 as follows:




