The funding string for the Transfer Out is 18 ORG 52430301, Fund 0135, Subclass 10000; and 19 WHEREAS, the Department of Behavioral Health has sufficient funding, \$479,867, for an 20 Intrafund Revenue to the Sheriff Org 31114000; and 21 WHEREAS, Section 29130 of the Government Code provides for the appropriation of 22 these funds by a four-fifths vote of the Board of Supervisors; 23 NOW THEREFORE.
