WHEREAS, the Local Health and Welfare Trust Fund 0135, 1991 Realign-Social Services Org 5246 received \$110,799 from the State of California for unbudgeted Caseload Sales Tax Growth revenues to meet unanticipated expense associated with the need as Operating Transfer Out to Aid to Adoptions Org 6415; and

WHEREAS, said monies are not included in the FY 2023-24 adopted appropriations of the 1991 Realign-Social Services Org 5246; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 1991 Realign-Social Services Org 5246 as follows:
