GRANT ORG 1146 IN THE AMOUNT OF \$20,037 )

**WHEREAS**, Probation Juvenile Facility Grant, Org 1146, requires \$20,037 to pay for the purchase of one TekNET and body scanner software, that were approved for purchase under Agreement No. A-25-196; and

**WHEREAS**, the Juvenile Facility Grant Org 1146 requires an increase in appropriations to fund an Operating Transfer Out in the amount of \$20,037 to the Probation Org 34409999; and

**WHEREAS**, sufficient funds are available in the fund balance of the Juvenile Justice Facility Grant Fund 0075, Subclass 17306, Org 1146, to fund these expenditures; and

**WHEREAS**, said monies are not included in the FY 2025-26 adopted appropriations of the Juvenile Facility Grant Org 1146; and

**WHEREAS**, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


