## RESOLUTION

WHEREAS, the County of Fresno Sheriff-Coroner Org 3111 will receive \$155,000 as an Operating Transfer In from the Debtor Assessment Fee Org 1454 and Sheriff Automated GC 26731 Org 1455 to purchase three new vehicles; and

WHEREAS, \$155,000 is not included in the adopted appropriations and estimated revenues of the Sheriff ORG 3111 for Fiscal Year 2015-16; and

WHEREAS, Section 29130 of the Government code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2015-16 Sheriff-Coroner Org 3111 appropriations as follows:




