**WHEREAS**, the National Association of Counties created the Aspire Award to recognize 457 deferred compensation plan sponsors who present measurable outcomes that result from unique, unusual, and original efforts to successfully engage county employees in their retirement futures; and

**WHEREAS**, Nationwide Retirement Solutions nominated the County of Fresno for the Aspire Award based on the County's "Save Today" Campaign, which is a week-long campaign focused on encouraging County employees to save more for their retirement, supported by daily emails from County staff and multiple site visits by Nationwide retirement specialists; and


**WHEREAS**, the "Save Today" Campaign was selected as the 2019 Aspire Award winner due to the outstanding results achieved by the collaborative efforts of the County and Nationwide, which has increased participation in the County's Deferred Compensation Plan from 36% in 2015 to 54% today; and

**WHEREAS**, the "Aspire Award: Creating Opportunities for County Employee Retirement Readiness" was presented to the County during the 84th Annual National Association of Counties Conference & Exposition on July 15, 2019 in Clark County, Nevada.

**NOW THEREFORE, BE IT RESOLVED** that the Fresno County Board of Supervisors hereby recognize and congratulate Director of Human Resources, Paul Nerland, Human Resources Manager Hollis Magill, Senior Human Resources Analyst David Joseph, and Human Resources Technician Samantha Arteaga for receiving the 2019 Aspire Award from the National Association of Counties for the "Save Today" Campaign.
