RESOLUTION

WHEREAS, the Local Health and Welfare Trust Fund 0135, Subclass 13046, Realign-Social Services Org 5246 will receive \$1,535,205 from the State of California for unbudgeted Sales Tax and Vehicle License Fees General Growth revenues to meet the need as Operating Transfer Out to Aid to Families with Dependent Children-Foster Care Org 6410; and

WHEREAS, said monies are not included in the FY 2021-22 adopted appropriations and estimated revenues of the Realign-Social Services Org 5246; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Realign-Social Services Org 5246 as follows:
