I, Bernice E. Seidel, Clerk of the Board of Supervisors (the "Board"), County of Fresno, California, acting in the official capacity of the Board's duly appointed Elections Official with regard to Community Facilities District No. 2006-01 (Police Protection Services) of the County of Fresno (the "District"), hereby certify as follows:

A. In my official capacity as the Elections Official, I consent to and I will conduct a special election for the District on January 28, 2025, as and when directed by the Board in its proposed Resolution No. R 25-022 (the "Resolution Calling a Landowner Special Election"), entitled "Resolution of the Board of Supervisors of the County of Fresno Calling a Special Election for a Vote of the Qualified Electors Within a Proposed Annexation Territory of Community Facilities District No. 2006-01 (Police Protection Services) of the County of Fresno, for the Combined Propositions of Levying a Special Tax to Finance Certain Services, and Including Such Annexation Territory in the District for Purposes of the Initial Appropriations Limit of the District," a copy of which is on file with my office. The landowner special election is further described in the Resolution Calling a Landowner Election.

B. I have reviewed and I am therefore familiar with the Boundary Maps of the original District, of territory subsequently annexed to the original District prior to the date of this Certificate (such territory has been added to and is part of and included in the District with full legal effect), and of the proposed Annexation Territory, all of which Boundary Maps are on file in my office. I have received from the Registrar of Voters of the County of Fresno certificates, dated as of December 17, 2024, indicating that as of the date of that certificate, 559 persons were registered to vote within the territory of the District, and certificates, dated as of December 17, 2024, and January 28, 2025, indicating that as of the dates of said certificates, three (3) persons were registered to vote within the territory of the proposed Annexation Territory. Those certificates are attached hereto and incorporated herein by reference.

C. Based upon the foregoing, and upon such other advice and information provided by staff of the County, I have determined that there were not, during each of the 90 days preceding January 28, 2025, at least twelve (12) persons,

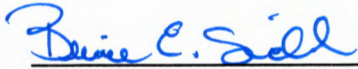
who need not necessarily be the same 12 persons, registered to vote within the territory of the proposed Annexation Territory prior to close of the Protest Hearing.

D. Based upon the foregoing, and upon such other advice and information provided by staff of the County, I have determined that there are 965 registered voters residing in the District, and three (3) registered voters residing in the proposed Annexation Territory, respectively.

E. In my official capacity as Elections Official, I concur in the shortening of various time periods applicable to said landowner special election, including, but not limited to, those time periods set forth in Government Code section 53326.

F. All capitalized terms in this certificate shall have the definition given to them in the Resolution Calling a Landowner Special Election, unless otherwise defined herein.
