1. Fully describe the product(s) and/or service(s) being requested.

The Department of Social Services (DSS) seeks to continue the Home Visiting Program (HVP) for California Work Opportunity and Responsibility to Kids (CalWORKs) participants within the existing contracted network of Neighborhood Resource Centers (NRCs) in both rural and metro Fresno County communities. All NRC contractors will continue provision of HVP to support positive health, development, and well-being outcomes for eligible pregnant and parenting women, families, and infants born into poverty.

The total cost is \$17,719,835. This includes three-year initial terms with a total annual cost of \$3,543,967, and two optional one-year renewals at an annual cost of \$3,543,967.
4. Identify the unique qualities and/or capabilities of the service(s) and/or product(s) that qualify this as a Suspension of Competition acquisition.

NRCs and HVP services are core components of DSS' child abuse prevention efforts. The current competitively-procured NRC are establishing themselves as trusted entities within the communities they serve. The addition of an evidence-base service such as HVP benefits the County as it strengthens the NRCs and furthers their capacity to provide an essential service to parents and their children.

By maintaining HVP within the existing infrastructure of NRCs, both Child Welfare and CalWORKs populations may continue to access valuable child abuse prevention, intervention and self-sufficiency supports within their immediate communities. Goals of HVP include reducing instances of child maltreatment, improving parent-child interactions, and promoting self-sufficiency, which directly align with the services offered by the current competitively-procured NRCs. As such, DSS seeks to continue to leverage the established infrastructure and maintain HVP within the array of services provided by the NRCs.

The current contracted providers are the only County-funded NRC providers within Fresno County. No other vendors were contacted.
