RESOLUTION

WHEREAS, the Sheriff-Coroner's Sheriff Automated GC 26731 Org 1455  
requires \$45,000 to meet needs for purchasing three vehicle computers, radios  
and associated equipment; and

WHEREAS, \$45,000 is available in the fund balance of the Special Revenue  
Sheriff-Coroner's Fund 0095, Subclass, 17654 to fund this expenditure; and

WHEREAS, \$45,000 is not included in the FY 2015-16 adopted  
appropriations of the Sheriff-Coroner's Sheriff Automated GC 26731 Org 1455;  
and

WHEREAS, Section 29130 of the Government Code provides for the  
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-  
Tax Collector is authorized to increase the appropriations in the FY 2015-16  
Sheriff-Coroner's- Special Revenue Fund 0095, Subclass 17654, Sheriff  
Automated GC 26731 Org 1455 as follows:




