RESOLUTION

WHEREAS, the BH Bridge Housing (BHBH) Grant Org 1084 requires \$8,792,105 to meet expenditures; and

WHEREAS, the BH Bridge Housing (BHBH) Grant Org 1084 requires an increase in appropriations and estimated revenues to fund an Operating Transfer Out in the amount of \$8,792,105 to the Behavioral Health Org 5630; and

WHEREAS, the Department of Behavioral Health will receive funds for the FY 2023-24 BH Bridge Housing (BHBH) Grant Org 1084; and

WHEREAS, said monies were not included in the adopted appropriations and estimated revenues for the FY 2023-24 BH Bridge Housing (BHBH) Grant Org 1084; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 BH Bridge Housing (BHBH) Grant Org 1084 as follows:
