IN THE AMOUNT OF \$2,429,186)

WHEREAS, the Interest and Miscellaneous Expenditures Org 2540 requires an increase in appropriations and estimated revenues in the amount of \$2,429,186 to fund a portion of the cost to purchase 64 pre-fabricated units to be used as dwelling units for women and families by the Fresno Mission; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Interest and Miscellaneous Expenditures Org 2540 for this purpose; and

WHEREAS, the Auditor-Controller/Treasurer-Tax Collector (ACTTC) – Disaster Claiming Fund 0026, Subclass 91021, ACTTC– Disaster Claiming Org 1033, received American Rescue Plan Act – Coronavirus State and Local Fiscal Recovery Funds to meet the needs as Operating Transfer In to the Interest and Miscellaneous Expenditure Org 2540; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the ACTTC is authorized to increase the appropriations in the FY 2021-22 Interest and Miscellaneous Expenditures Org 2540 as follows:
