RESOLUTION

WHEREAS, the County of Fresno will receive \$104,315 from the sale of surplus vehicles and sale of wrecked and scrap vehicle materials; and

WHEREAS, \$41,185 of a reimbursement credit from a previously ordered vehicle that was never completely built nor delivered to fund the purchase of Sheriff’s Non-patrol Vehicles; and

WHEREAS, said monies are not included in the FY 2021-22 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31113229; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Sheriff-Coroner-Public Administrator ORG 31113229 as follows:
