RESOLUTION

WHEREAS, the County of Fresno, Department of Public Works and Planning is charged with operations and maintenance of 3,488.48 miles of roadway within Fresno County; and

WHEREAS, an emergency repair of a slope failure on a section of Huntington Lake Road, located three-quarters of a mile north of the town of Big Creek, is listed in the County's maintained mileage program; and

WHEREAS, Huntington Lake Road is an essential evacuation route serving the town of Big Creek and Huntington Lake Basin; and

WHEREAS, the Road Fund 0010 has \$800,000 available to repair the damaged section of roadway; and

WHEREAS, said funds are not included in the adopted appropriations of the FY 2018-19 Public Works and Planning- Roads Org 4510; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by four-fifth vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller Treasurer –Tax Collector is authorized to increase the appropriations in the FY 2018-19 Public Works and Planning Org 4510 as follows:


