ORGANIZATION 8830 IN THE AMOUNT OF \$137,700)

WHEREAS, additional work is required to be performed at the Juvenile Justice Campus consisting of additional ventilation in the boiler room at the Juvenile Justice Campus Central Plant (the "Additional Work"); and

WHEREAS, there are available funds due to the interest earnings within the Juvenile Justice Campus Capital Projects fund to support the increase in appropriations; and

WHEREAS, \$137,700 is available in the Fund Balance of the Capital Projects Fund 0400, Subclass 10100 to fund these expenditures; and

WHEREAS, said monies are not included In the adopted appropriations for the FY 2016-17 Juvenile Justice Campus Organization 8830 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2016-17 appropriations in the Juvenile Justice Campus Organization 8830 as follows:
