WHEREAS, the Integrated Waste Management Org 1156 requires \$26,213 to meet expenditures associated with the purchase of a Gas Extraction Monitor; and

WHEREAS, the Integrated Waste Management Org 1156 will receive additional funding from the California Department of Resources Recycling and Recovery (CalRecycle) Grant in the amount of \$26,213 in FY 2016-17 to fund an Operating Transfer Out to the Department of Public Health Org 5620 ; and

WHEREAS, \$26,213 is not included in the FY 2016-17 adopted appropriations and estimated revenues of the Integrated Waste Management Org 1156; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Integrated Waste Management Org 1156 as follows:




