BEFORE THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO STATE OF CALIFORNIA ORDINANCE NO. R- 499 -3862

AN ORDINANCE TO CHANGE, PURSUANT TO THE CERTIFIED PROGRAM ENVIRONMENTAL IMPACT REPORT PREPARED FOR THE GENERAL PLAN REVIEW AND ZONING ORDINANCE UPDATE, THE BOUNDARIES OF CERTAIN ZONES AND THE ZONING DISTRICT OF PROPERTY THEREBY AFFECTED IN ACCORDANCE WITH THE PROVISIONS OF THE ZONING DIVISION OF THE ORDINANCE CODE OF FRESNO COUNTY, AND TO AMEND THE ZONE MAP ESTABLISHED BY SAID DIVISION ACCORDINGLY.

The Board of Supervisors of the County of Fresno ordains as follows:

SECTION 1. This Ordinance is adopted pursuant to California Constitution, Article XI, Section 7, Government Code Sections 65850, 65854-65857, and Sections 811 and 878 of the Ordinance Code of Fresno County.

SECTION 2. Whereas the Program Environmental Impact Report prepared for the General Plan Review and Zoning Ordinance Update (Project) which considered this Ordinance, was certified by the Board pursuant to Board Resolution, which also adopted a Mitigation Monitoring and Reporting Program (MMRP).

SECTION 3. All that portion of the unincorporated area of the County of Fresno consisting of bounded by Friant Road/Willow Avenue to the west, Garonne Avenue to the south, those parcels immediately east and adjacent to Auberry Road to the east and generally the Birkhead Road alignment to the north and encompassing those parcels immediately to the west, northeast and east of the full length of Willow Bluff Avenue located approximately one-half mile north of the city limits of the City of Fresno from AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) District to the AL (Limited Agricultural) District.

These parcels are more particularly displayed as shown in Exhibits "A", and as listed in Exhibit "B".

1	SECTION 4. Now, therefore, it is hereby resolved that the Board finds that the Project's certified			
2	Program Environmental Impact Report fully considered this Ordinance and that per Board Resolution,			
3	this Ordinance is subject to the adopted MMRP.			
4	SECTION 5. Prior to the expiration of fifteen (15) days from the adoption of this Ordinance, it			
5	shall be published in accordance with the requirements of Government Code Section 25124 at least one			
6	time in the Fresno Business Journal, a newspaper of general circulation in Fresno County.			
7	SECTION 6. In accordance with Government Code Sections 25123, 25131, an			
8	65854-65857, this Ordinance, designated as Ordinance No. R- 499 -3862 shall take effect thirty			
9	days after its passage.


