WHEREAS, the County of Fresno has received \$25,000 from an insurance settlement and \$136,619 from the sale of surplus vehicles; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31113229; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Sheriff-Coroner-Public Administrator ORG 31113229 as follows:


