WHEREAS, funds are needed to cover expenditures related to the administration of the Agreement with local Managed Care Plans for Medi-Cal Grant funding; and

WHEREAS, \$161,453 will be available in the FY 2026-27 estimated revenues of the Housing and Homelessness Fund 0023, Subclass 17129 Medi-Cal – HHIP & IPP Org 0129 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2026-27 adopted appropriations and estimated revenues of the Office of Housing and Homelessness Org 5428; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2026-27 Office of Housing and Homelessness Org 5428 as follows:

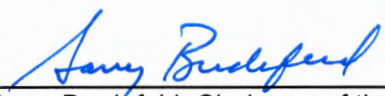

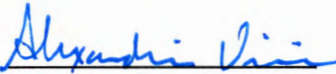
