WHEREAS, the Hall of Records Improvements, Organization (Org) 8861, requires an increase in appropriations to fund an Operating Transfer Out in the amount of \$1,950,750 to the County Buildings, Org 0131; and

WHEREAS, the total costs for the purchase of property located at 2126-2140 Merced Street, Fresno, CA 93721, is estimated at \$1,950,750;

WHEREAS, sufficient funds are available in the Fund Balance of the of the Capital Projects Fund 0400, Subclass 10061 to fund the costs related the purchase of property; and

WHEREAS, said monies are not included in the adopted appropriations for the FY 2025-26 Hall of Records Improvements, Org 8861 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2025-26 Hall of Records Improvements, Org 8861 as follows:


