WHEREAS, the County of Fresno will receive a check donation of \$10,000 to purchase a canine from Valley Crime Stoppers (Fresno Crime Stoppers Program Inc.); and

WHEREAS, \$10,000 is not included in the appropriations and estimated revenues of the Sheriff-Coroner Organization 3111 for FY 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2017-18 appropriations in the Sheriff-Coroner Organization 3111 as follows:

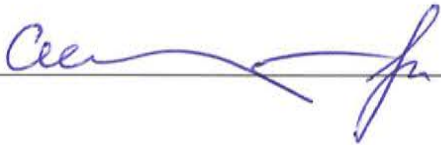

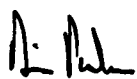

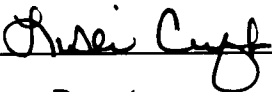
