WHEREAS, the County of Fresno will receive approximately \$197,000 from the Proposition 218 rate increase approved by your Board on June 24, 2025; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of County Service Area 44D – Monte Verdi (CSA 44D); and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 appropriations for CSA 44D, Org 9247 as follows:
