14 A, attached hereto and incorporated by this reference.

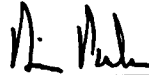
15 SECTION 2: This Ordinance shall take effect and be in force and effect July 1, 2017.

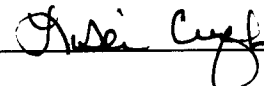

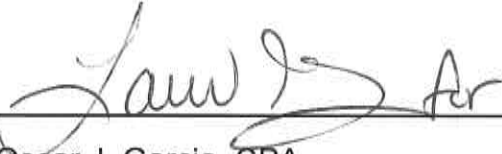
