WHEREAS, the Blue Hills Hazardous Disposal Facility is regulated by the
Department of Toxic Substances Control (DTSC); and

WHEREAS, DTSC requires the County of Fresno to enter into an Agreement for
Processing an application for a Hazardous Waste Facility Post Closure Permit
estimated at \$300,419; and

WHEREAS, the Misc Pass-Through Organization 43601250 will receive
\$300,419 through an Operating Transfer In from the Coalinga Disposal Site
Organization 9028 to funds these expenditures; and

WHEREAS, said monies are not included in the adopted appropriations and
estimated revenues of the FY 2017-18 Misc Pass-Through Organization 43601250; and

WHEREAS, Section 29130 of the Governmental Code provides for the
appropriation of these funds by a 4/5ths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax
Collector is authorized to increase the appropriations in the FY 2017-18 Budget for Misc
Pass-Through Organization 43601250 as follows:
