PUBLICATION OF SUMMARY OF PROPOSED ORDINANCE BOARD OF SUPERVISORS COUNTY OF FRESNO

The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on January 9, 2024, at 9:30 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

To amend the Fresno County Master Schedule of Fees (MSF), Charges and Recovered Costs by revising Subsection 3305 of Section 3300 to increase the business location fee caps, and increase the commercial weighing and measuring device fee caps for water submeters, vapor meters, computing and electronic counter scales interfaced with a cash register or any point-of-sale system, produce scales and the category of all other commercial weighing and measuring devices. Additionally, the combined business location and device fee cap will increase for specified locations and commercial weighing and measuring devices.
