NEPA Letter

***DNA Capacity Enhancement for Backlog Reduction (CEBR) Program provides funding to states and units of local government with existing crime laboratories to increase the capacity of publicly funded forensic DNA and DNA database laboratories to process more DNA samples, thereby helping to reduce the number of forensic DNA and DNA database samples awaiting analysis and/or prevent a backlog of forensic and database DNA samples.***

All recipients of funding under this award must assist the Office of Justice Programs (OJP) in complying with NEPA and other related federal environmental impact analyses requirements in the use of grant funds, whether the funds are used directly by the recipient or by a subrecipient or third party. Accordingly, prior to obligating funds for any of the activities specified below, the grantee must first ensure compliance with OJP NEPA procedures.

The specified activities requiring environmental analysis are:

- (1) New construction
- (2) Any renovation or remodeling of a property located in an environmentally or historically sensitive area, including property (a) listed on or eligible for listing on the National Register of Historic Places, or (b) located within a 100-year flood plain, a wetland, or habitat for an endangered species
- (3) A renovation that will change the basic prior use of a facility or significantly change its size
- (4) Research and technology whose anticipated and future application could be expected to have an effect on the environment
- (5) Implementation of a program involving the use of chemicals (including the identification, seizure, or closure of clandestine methamphetamine laboratories)

Complying with NEPA may require the preparation of an Environmental Assessment and/or an Environmental Impact Statement, as directed by OJP. Further, for programs relating to methamphetamine laboratory operations, the preparation of a detailed Mitigation Plan will be required. Please be sure to carefully review the grant conditions on your award document, as it may contain more specific information about environmental compliance.

FY 2021 DNA Backlog Reduction Capacity Enhancement Program - Fresno County Sheriff's Office Abstract The geographic location of Fresno County is approximately an equal distance between the major metropolitan areas of San Francisco and Los Angeles in the Central San Joaquin Valley. From east to west, the County's boundaries extend 135 miles, encompassing a geographical area of 6,017 square miles with the Coast Mountain Range to the west and the Sierra Nevada Mountain Range to the east. Fresno County has a population of 965,974 that is expected to grow 3% annually in the future. The Fresno County Sheriff's Office Forensic Laboratory provides services for the Fresno County Sheriff's Office. The forensic laboratory has four Criminalists that are trained and qualified to perform STR analysis. Due to staffing needs and the growing demand for DNA analysis, the Fresno County Sheriff's Office Forensic Laboratory needs to find a way to reduce backlogged DNA casework and increase our capacity. The Sheriff's Office has over 20 unsolved homicide/rape cases that need to be examined for potential DNA evidence. DNA cases can take from 60 to 90 days from request to final report, due to the size of our staff and the amount of samples that detectives are requesting. The forensic laboratory is seeking \$350,448 in federal funds to decrease the backlog/turnaround time and to increase the capacity of cases from the DNA unit. This will be accomplished by using grant funds to continue funding one Criminalist position, send DNA four staff members to the 2023 ISHI conferences, purchase ten digital SLR cameras, four analytical balances, one digital camera station computer, twelve camera station monitors, six stereo microscopes, maintenance service contracts for two 3500 Genetic Analyzers, 5 licenses and maintenance contracts for STRmix computer systems and use funding for private fee

for services vendors to reduce the number of backlogged DNA cases. The result will be a reduction in the number of days from request to issuing final DNA results to our clients and a reduction in the numbers of backlogged DNA cases.

The recipient shall ensure that all forensic DNA analyses conducted with funding under this award are performed either (1) by accredited government-owned laboratories, or (2) through accredited fee-for-service vendors. Accreditation must be by a nonprofit professional association of persons actively involved in forensic science that is nationally recognized within the forensic science community. The recipient shall ensure that any laboratory that conducts forensic DNA analyses under this award undergoes external audits, not less than once every two years, that demonstrate compliance with the Quality Assurance Standards for Forensic DNA Testing Laboratories established by the Director of the Federal Bureau of Investigation. The recipient shall ensure that all eligible forensic DNA profiles obtained with funding under this award will be entered into the Combined DNA Index System (CODIS), and, where applicable, uploaded to the National DNA Index System (NDIS). No profiles generated with funding from this award may be entered into any non-governmental database without prior express written approval from BJA. If any government-owned forensic laboratory that will receive funding under this award to conduct forensic DNA analyses is not a member of NDIS, the laboratory must have a written agreement in place with an NDIS-participating laboratory for the resulting eligible forensic DNA profiles to be entered into CODIS, and, where applicable, uploaded into NDIS.
