ORG 6645 IN THE AMOUNT OF \$714,170)

WHEREAS, the General Relief Org 6645 has identified the need to increase an additional \$714,170 in appropriations in order to issue payments to the General Relief Program; and

WHEREAS, the General Relief Org 6645 will receive \$714,170 in revenues as Net County Cost (\$574,568), Interim Assistance Reimbursement (\$135,847) and Welfare Repayments (\$3,755); and

WHEREAS, said monies were not included in the FY 2024-25 adopted appropriations and estimated revenues of General Relief Org 6645 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 General Relief Org 6645 follows:




