WHEREAS, the County of Fresno received \$892,346 from the State of California Board of State and Community Corrections (BSCC) the Coronavirus Emergency Supplemental Funding (CESF) administered by the U.S. Department of Justice, Bureau of Justice Assistance; and

WHEREAS, said monies were not included in the FY 2020-21 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 31111019; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Sheriff-Coroner-Public Administrator Organization 3111 as follows:


