WHEREAS, as a Condition of Approval of Parcel Map No. 7873 (PM 7873), the Fresno County Board of Supervisors (Board) required the formation of a zone within County Service Area (CSA) 35 to fund the maintenance of roads serving properties within PM 7873; and

WHEREAS, Zone CA of CSA 35 (CSA 35-CA), more particularly described in Exhibit A to this resolution, was formed on November 25, 2003, to provide for the maintenance of a road benefiting parcels within PM 7873; and

WHEREAS, the road constructed to serve properties within CSA 35-CA, bearing the name West Melrose Avenue, is dedicated for public use, and accessible to the public, but not accepted into the County-maintained road system; and

WHEREAS, road maintenance for West Melrose Avenue is currently funded by benefit assessments levied by the Board by resolution #03-547 on November 25, 2003, on real property in CSA 35-CA; and

WHEREAS, the owners of the property in CSA 35-CA applied to the County for dissolution of CSA 35-CA and vacation of West Melrose Avenue by the County because they wish to install a security gate to close West Melrose Avenue to public traffic to improve safety and security of their property, and to prevent illegal activity along West Melrose Avenue; and

WHEREAS, the Melrose Lane Homeowners Association has been established by the owners of property in CSA 35-CA to provide road maintenance for West Melrose

Avenue, by recording "Declaration of Covenants, Conditions and Restrictions for Melrose Lane" on February <u>26</u>, 2016 (Document No. <u>2016-0024395</u>), and the Director of Public Works and Planning has determined that is an acceptable method of providing road maintenance, as required by Fresno County Ordinance Code section 17.48.460; and

WHEREAS, the Board, by resolution <u>16-038</u> on February 2, 2016, determined that it is in the public interest and declared its intent to dissolve CSA 35-CA under Title 3, Division 2, Part 2, Chapter 2.5, Article 8 of the California Government Code, and set a public protest hearing at 11:00 a.m., or as soon after as circumstances perit, on March 1, 2016, in the meeting chambers of the County of Fresno Board of Supervisors, Hall of Records, 2281 Tulare Street, Third Floor, Fresno, California 93721; and

WHEREAS, the Clerk to the Board gave notice of the public protest hearing as follows pursuant to section 25217, subdivision (d), of the California Government Code:

- Published the notice of the protest hearing pursuant to California
 Government Code Section 6061 in a newspaper of general circulation,
 published in the County, which notice included the information required by
 Section 25217, subdivision (b), of the California Government Code;
- 2. Mailed the notice to all owners of property within CSA 35-CA;
- Mailed the notice to each city and special district that contains, or whose Sphere of Influence contains CSA 35-CA, which includes only the City of Fresno; and
- 4. Posted the notice in at least three public places within CSA 35-CA.

WHEREAS, the Board conducted a public protest hearing at 11:00 A.M., or as soon after as circumstances permitted, on March 1, 2016, in the meeting chambers of the County of Fresno Board of Supervisors, Hall of Records, 2281 Tulare Street, Third Floor, Fresno, California 93721, concerning the proposed dissolution of CSA 35-CA.

WHEREAS, the Board has received certification from the County Clerk/Registrar of Voters that zero registered voters reside within CSA 35-CA;

WHEREAS, written protests to the proposed dissolution were not filed by more



- (4) North 00°46'38" East, along the West line of the East 47.00 feet of the South half of the Northeast quarter of the Southeast quarter of said Section 34, a distance of 658.87 feet to the POINT OF BEGINNING.
