RESOLUTION INCREASING THE SEWER SERVICE FEES FOR SEWER SERVICE PROVIDED THROUGH COUNTY SERVICE AREA NO. 34, ZONE C

WHEREAS, County staff initiated the process under California Constitution Article XIII-D (Proposition 218) to increase sewer service fees for the 161 residential lots, receiving sewer service through County Service Area No. 34, zone C (CSA 34C); and

WHEREAS, as part of that process, a notice of the proposed increased sewer service fee was mailed on January 15, 2016, to each record owner of property receiving sewer service through CSA 34C, as shown on the last equalized assessment roll, upon which the increased sewer service fee was proposed for imposition; and

WHEREAS, the notice mailed on January 15, 2016, described the amount of the proposed increased sewer service fees, the basis upon which the proposed increased sewer service fees were calculated, the reason for the proposed increased sewer service fees, and the date, time, and location of the public protest hearing on the proposed increased sewer service fees; and

WHEREAS, although not required by law, County staff on February 3, 2016, at 6:00 p.m., conducted a public meeting at the Friant Elementary School, 17200 Burroughs, Friant, CA 93626, to provide members of the public with an opportunity to give relevant testimony and ask questions about the proposed increased sewer service fees; and

WHEREAS, a public protest hearing was held on March 1, 2016, before the Board of Supervisors, at which time opportunity was provided for public comment, oral protests, and submission of written protests by owners or tenants of property receiving sewer services through County Service Area No. 34C, upon which the increased sewer service fees was proposed; and

WHEREAS, the Clerk to the Board of Supervisors or her designee, at the end of					
the public protest hearing, tabulated the written protests received and determined that					
majority of owners or tenants of property receiving sewer services through CSA 34C,					
upon which the increased sewer service fees were proposed, did not submit written					
protests to the proposed increased sewer service fees.					
THEREFORE BE IT RESOLVED, based on the results of the protest hearing,					
there was no majority protest and the fees, as set forth in Exhibit A, shall become					
effective July 1, 2016, and shall be published in the Master Schedule of Fees, Charges					
and Recovered Costs for administrative purposes only.
