WHEREAS, the County of Fresno will receive \$797,235 from the Edward Byrne Memorial Justice Assistance Grant, of which the Sheriff's Office will receive \$500,000; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Sheriff-Coroner-Public Administrator Org 3111 as follows:


